## A. <u>POLICY</u>

Any two of the following officers of the Workers Compensation Board (WCB) are authorized to sign cheques or to have their signatures affixed by a mechanical signing device, and to have access to the safety deposit box:

President and Chief Executive Officer Vice President and Chief Financial Officer Chief Investment Officer Director, Finance Manager, Financial Reporting Manager, Budget, Purchasing and Payables

The Royal Bank of Canada is authorized and directed to honour, pay and charge to the accounts of the WCB, any and all cheques signed and completed in the above manner.

For the purpose of the WCB Assessment Department Account, any two of the following officers of the WCB are authorized to sign cheques or to have their signatures affixed by a mechanical signing device:

President and Chief Executive Officer Vice President and Chief Financial Officer Director, Finance Supervisor, Collections Manager, Financial Reporting Manager, Budget, Purchasing and Payables
