 ✓ Medical services provided under a Regional Health Authority 	 Coverage for medical offices and clinics where treatment is provided by any of the following: doctors, nurses, dentists (including orthodontists), chiropractors, occupational therapists, optometrists, physiotherapists, psychologists and podiatrists is optional and is found under 924-03, "Medical & Personal Services".
 Provision of medical and personal care where overnight accommodations are provided. Includes facilities such as: Hospitals Medical nursing units Nursing homes 	Residential facilities that provide personal care only to their residents (room cleaning service, preparation of meals, activities, etc.) but no medical, surgical or nursing care are found under 702-03, "Specialized Homes".
 Private firms that provide medical service personnel to a hospital or home care to the elderly or infirm (e.g., supplying nurses to a hospital) 	 A person (not a business) that hires an individual, such as nurses-aides or other health care attendants, to provide care for patients in their own home (self-managed home care), are classified under rate code 706-03, "Domestics". (Coverage is only mandatory if the worker is employed for 24 hours or more per week.)

 Provision of Emergency Medical Technicians (EMT) or paramedic services. 	The provision of lifeguards to patrol beaches or pools is found under 701-07, "Security Services".
 The operation of an ambulance service that includes emergency medical treatment by a qualified EMT/paramedic. 	 Firms providing transportation to and from medical appointments or treatments, including wheelchair and stretcher services, where medical assistance is not provided, are found under 503-09, "Transportation NEC". Emergency volunteer ambulance drivers are found under 802-03, "Emergency Ambulance Workers".

Relevant Exclusion(s): Schedule A, Regulation 169/2008, WCA

Health care services

16(1) Provision of health care services by a physician, nurse, dentist, chiropractor, occupational therapist, optometrist, physiotherapist, podiatrist or psychologist.

(This category does not include

- (a) those health care services provided in conjunction with a manufacturing or retail components; or
- (b) those health care services provided
 - (i) by a regional health authority or a subsidiary health corporation under *The Regional Health Authorities Act*;
 - (ii) by a firm that provides medical services at a hospital or home cares services to the elderly or infirm, or
 - (iii) in a facility offering medical care and overnight accommodation.)
