<ul> <li>Operation of a recreational facility or activity, including:</li> <li>Miniature golf course</li> <li>Driving range</li> <li>Batting cages</li> <li>Go-cart tracks</li> <li>Amusement parks</li> <li>Skate board parks</li> <li>Waterslides</li> <li>Ski resorts (no overnight accommodation)</li> <li>Horse race tracks</li> <li>Swimming pools</li> <li>Petting zoos</li> <li>Corn mazes</li> <li>Zip lines</li> <li>Facilities may offer incidental rentals (watercraft, golf clubs, etc),</li> </ul>	<ul> <li>Recreational facilities operated by a private, semi-private or public/community club are found under 901-04, "Arcades, Bowling, Billiards, Recreational Clubs &amp; Rinks".</li> <li>Coverage for campgrounds, trailer parks and playgrounds, as well as hunting and fishing guiding and canoe excursions is mandatory and are found under 710-03, "Day Camps &amp; Parks".</li> <li>Coverage for the operation of a ski lodge offering overnight accommodations is mandatory and is found under 701-05, "Resorts &amp; Lodges".</li> <li>Recreational facilities operated by a town, city, municipality, etc., are incidental to the main operation and are found under 801-02, "Municipal Operations".</li> </ul>
