Section Title: Board and Corporate Administration - Board Administration

Subject: Non-substantive and Consequential Policy Changes

Effective Date: July 1, 2019

A. POLICY PURPOSE

The purpose of this Policy is to describe the Corporate Secretary's authority to approve non-substantive and consequential policy changes.

B. POLICY

The Board of Directors authorizes the Corporate Secretary to make changes of the type listed below to the WCB's published policy documents:

- 1. Changes of any type to the non-policy parts of policy documents or the Policy Manual including title pages, pages explaining how the policies are organized, indexes, table of contents, or the references and history sections of individual policies;
- 2. The correction of cross references in other policies to new, revised or rescinded policies which have been approved by the Board of Directors;
- 3. Grammatical or style changes that do not affect meaning;
- 4. Changes to titles of WCB Staff, sections, departments or divisions where the changes only affect internal operations and do not affect the rights or responsibilities of workers, dependants of deceased workers or employers;
- Changes in titles or persons or things, or of wording from sources outside the control of the WCB when there is no change in the substance of the applicable law, regulation or policy;
- 6. Changes that are the automatic result of a formula in *The Workers Compensation Act,* regulation, policy or other applicable legislation;
- 7. Consequential amendments to individual policies resulting directly from decisions of the Board of Directors; and
- 8. Changes that are directed solely at improving administration or procedure and do not affect the rights or responsibilities of workers, dependants of deceased workers or employers.

The Corporate Secretary will report on all changes made under numbers 1 to 8 above at every meeting of the Governance Committee.
